DEAR NICOLE:

PER SEC. 13(1)(A) AND (B)(III) OF THE MICHIGAN FREEDOM OF INFORMATION ACT AND HIPAA PRIVACY LAWS, PERSONAL AND/OR MEDICAL INFORMATION IS BEING REDACTED AS THE DISCLOSURE OF THE INFORMATION WOULD CONSTITUTE A CLEARLY UNWARRANTED INVASION OF AN INDIVIDUAL'S RIGHT TO PERSONAL PRIVACY.

THIS RESPONSE FULLY ADDRESSES YOUR FOIA REQUEST, AND THEREFORE, I CONSIDER MY RESPONSE COMPLETED. HOWEVER, UNDER MCL §15.240, YOU HAVE THE RIGHT TO SUBMIT A WRITTEN APPEAL, TO THE HEAD OF THE PUBLIC BODY (BERRIEN COUNTY SHERIFF L. PAUL BAILEY), THAT SPECIFICALLY STATES THE WORD "APPEAL" AND IDENTIFIES THE REASON OR REASONS WHY THE DENIAL SHOULD BE REVERSED. IN THE ALTERNATIVE, YOU MAY COMMENCE A CIVIL ACTION IN THE BERRIEN COUNTY CIRCUIT COURT TO REQUEST A JUDICIAL REVIEW OF THIS DENIAL AND REQUEST ATTORNEY FEES AND DAMAGES IF THE COURT DETERMINES THAT THE PUBLIC BODY HAS NOT COMPLIED WITH MCL 15.235 IN ITS DETERMINATION TO DENY A REQUEST.
